DIRECTIONS

From New Haven, Hartford, Fairfield County:

I-95 north to exit 50 (Woodward Avenue/Lighthouse Point). Stay in right hand lane. Bear right, following signs to "Port Area". Go left at the second stop sign. Colony is on your left.

From East Haven and Shoreline:

I-95 South to Exit 51 (Frontage Road/Lighthouse Point). Go straight for 1.2 miles to Stiles Street. Left onto Stiles Street for 2/10 of a mile. Colony is on the left hand side.

DIRECTIONS

From the South Shore:

93N to Exit #13. Turn left at the end of the exit ramp. Take next right onto Freeport Street. Go straight through first set of lights, crossing over Morrissey Blvd, stay on Freeport Street. Colony is three blocks up on the left.

From the North Shore:

93S to exit #15. Turn left at the end of the exit and follow to rotary. Take the first right out of the rotary and follow Morrissey Blvd. past Boston College High School (on the left) and The Boston Globe (on the right). Go through the first set of lights. At second set of lights take a right onto Freeport Street. Colony is three blocks up on the left.

DIRECTIONS

From the South:

87N merge onto 87N/190E to Exit 24 towards Albany/Montreal. Merge onto 87N toward Albany Airport. Take Exit 2E (Rt. 5) toward Albany. Slight right onto Central Ave. Turn right onto Interstate and #4 is on your left.

From the West:

90E toward Albany. 87N Exit 1N/Rt. 5E. Exit 2E, turn slight right onto Central Ave. Right onto Interstate. #4 is on your left.

From the East:

90W to Everett Rd. Exit 5. Left on Everett. Right on Central Ave. Left on Interstate. #4 is on left.

From the North:

87S to Rt 5E (Exit 2E) toward Albany. Turn slightly right onto Central Ave. Turn Right on Interstate. #4 is on left.

DIRECTIONS

From the South:

Take Interstate 95 N/Interstate 495 E ramp to Baltimore/Interstate 295. Take Exit 2B, merge onto I-295 N toward Washington. Continue onto District of Columbia Hwy 295 (signs for I-95 N/Baltimore/US-50 E/Annapolis). Take the exit onto US-50 E towards Annapolis. Take the Columbia Park Road Exit towards Cheverly. Turn right onto Columbia Park Road. Follow Columbia Park Road for .8 miles. Turn right onto Stanford Court. #1950 is on the right.

From the West:

Follow Route 66 East to exit 64A, I-495 South towards Richmond. Take the Interstate 95/Interstate 495 Exit. Merge onto I-495E/I-95N. Take Exit 2B to merge onto I-295 N toward Washington. Continue onto District of Columbia Hwy 295 (signs for I-95 N/Baltimore/US-50 E/Annapolis). Take the exit onto US-50 E towards Annapolis. Take the Columbia Park Road Exit towards Cheverly. Turn right onto Columbia Park Road. Follow Columbia Park Road for .8 mile. Turn right onto Stanford Court. #1950 is on the right.

From The East:

Take US 50 W towards Washington DC to Exit 8, MD-704 (M.L. King Jr. Hwy) toward Glenarden S. Turn left onto MD 704/ Martin Luther King Jr. Highway. Follow for 3.3 miles. Turn right onto Columbia Park Road. Follow for 1.1 miles, Turn left onto Stanford Court. #1950 is on the right.

From The North:

Follow Interstate 95 South to I495E/I-95S. Follow to Exit 7A Route 50 West towards Washington, DC. Take Route 50 West to the Kenilworth Avenue Exit. Make right onto Kenilworth Avenue then make immediate right onto Tuxedo Road. Continue on Tuxedo Road, cross back over top Route 50 and follow for .8 mile. Turn right onto Stanford Court. #1950 is on the right.

From the District:

Take New York Avenue East which will turn into Route 50 East. Cross under Route 295 (Baltimore/Washington Parkway). Take Columbia Park Road/Cheverly Metro Exit. Make Right onto Columbia Park Road. Follow for .8 mile. Turn right onto Stanford Court. #1950 is on the right.

From Old Colony Location (8051 Penn Randall Place):

Get on I495N/I-95N toward Baltimore. Take Exit 17, Route 202. Make left on Route 202. Cross back over Beltway. Follow for 1 mile to MD 704S (Martin Luther King Jr. Hwy) towards Seat Pleasant. Merge onto MD 704. Follow for .8 mile and make right onto Columbia Park Road. Follow Columbia Park for 1.1 miles and make left onto Stanford Court. #1950 is on the right.
